

SUBJECT: Priority Vaccination (COVID-19) of Faculty, Non-Teaching Staff, Students, and Misc staff.

With reference to email dated 09-08-2021, received from Ms. Sadaf Tahir, Assistant Director (Coordination), Higher Education Commission (HEC), Islamabad (copy enclosed for ready reference), you are hereby requested to ensure implementation of following directives of HEC:

- All faculty, non-teaching staff, and students of the University are fully vaccinated by August 31, 2021. After August 31, 2021, the entry of non-vaccinated (including partially vaccinated faculty, staff, and students) should not be allowed in the University's premises.
- Ensure mandatory vaccination of all eligible students and students may be guided about the vaccination facilities (list of vaccination centres may be accessed at https://ncoc.gov.pk/facilities/MVCs_CVCs.pdf).
- No entry of any non-vaccinated faculty member, non-teaching staff, and student even with partial vaccination should be allowed after the prescribed date.
- No student should be allowed to stay at University Hostel without complete vaccination.
- Only NADRA Vaccination Certificate should be used as proof of vaccination.
