The meeting of the Central Purchase Committee (CPC) held on, Wednesday 11th December 2024 for opening of bids vide EPADS for Procurement of Services titled "Venue setup, Furniture/Fixture, Food, Refreshment, Photography, Videography, Printing Material - Convocation LUMHS Jamshoro-2024"; five bidders (in multiple LOTS) submitted their bids in respect of subject NIT till deadlines of submission. The following bidders submitted their bids till the deadline of submission:

The Bids were opened at 11:30 am dated 11-12-2024 in the presence of the participants and members of committee. The financial bids quoted by bidders in different lots were read aloud. Following are the details of bids announced:

Additionally, M/s Xpert Enterprises, has not accepted by CPC for further evaluation at the time of opening of bids owing to discrepancy in its submission, that is, M/S Xpert Enterprises submitted its bid in LOT A but on the contrary documents showed that the firm has quoted for LOT C & D thus has been rejected. Moreover, due to arithmetic error in financial proposal of M/S Shan Printing Press Hyderabad (LOT D), the total amounting with Rs. 2,52000/- increased thus new total makes to 4.234 Million instead of 3.982 Million.

The committee shall examine the bid as per the qualification / eligibility criteria provided in the bidding documents, arithmetical checks and verify the documents and bid security submitted by the bidders.
