The Bidding shall be on Single Stage Two Envelopes procedure. First Envelope should contain Technical Proposal and DD/Pay Order Rs. 1,000/= (Rupees One Thousand) (Non Refundable) & be clearly marked as TECHNICAL PROPOSAL.

Second Envelope should contain Financial Proposal (Rates), in Pak Rupees along with the Bid Money @ 2% of Quoted Price for the First Year in the shape of Pay Order/Demand Draft (refundable to un-successful Bidders) in favour of Vice Chancellor, LUMHS, and the Envelope be clearly marked as FINANCIAL PROPOSAL.

Both the Envelopes should be sealed separately and placed in the Third Envelope. The Name of the Bidder be clearly marked on all the Envelopes.

After the evaluation & approval of the Technical Proposals by the Technical Committee on the basis of required Documents/Certificates mentioned above and Terms & Conditions, the LUMHS shall at a time within the Bid Validity of minimum of 90 Days publicly, open the Financial Proposals of the Technically accepted Bids only, on the Date and Time to be communicated later by this University to the Technically approved Bidders. The Financial Proposals of Bids found technically non-acceptable shall be returned without opening Financial Proposals to the respective Bidders.

The Central Purchase Committee may reject any Bid subject to the relevant provisions of SPPRA Rules and may cancel the Bidding Process at any time prior to acceptance of any Bid or Proposal as Rule 25 (1).

Government notified Black Listed Firms / Suppliers shall not be entertained.

In case the Tenders are not opened on the Scheduled Date due to Unscheduled Holiday then the same shall be submitted & opened on Next Working Day. The other Terms and Conditions of the Tender shall however remain unchanged.
