& be clearly marked as TECHNICAL PROPOSAL. Second Envelope should contain Financial Proposal (Rates) in Pak Rupees or C&F Basis, along with the Earnest / Bid Money @ 5% of Quoted Rates in the shape of Pay Order/Demand Draft (refundable to un-successful Bidders) in favour of Vice Chancellor, LUMHS, and the Envelope be clearly marked as FINANCIAL PROPOSAL.
