a)	Tenders shall be opened by Procurement Committee in presence of bidders or their authorized representatives who wish to be present.
b)	In case of holiday or any incident, the tenders will be obtained / submitted / opened on the next working day as per given schedule
c)	All required certificates / documents along with GST/NTS Certificate, Professional Tax Certificate, SRB etc must be attached with the technical proposal for tender.
d)	All prescribed taxes applicable under federal / provincial / local government shall be borne by bidder / supplier himself.
e)	Single-Stage – Two-Envelops Procedure shall be adopted for the procurement as per SPPRA Rules 2010.
f)	Technical Proposal and Financial Proposal marked in bold and legible letters should be kept in one envelope duly sealed. Bid security 03% of total bid value in favour of Vice Chancellor, Liaquat University of Medical & Health Sciences, Jamshoro.
	The Technical Proposal will be opened on the day of opening of tender. After the evaluation of the Technical Proposals by the Technical Committee on the basis of requirement, the LUMHS shall at a time within the bid validity of minimum of 90 days publicly, open the financial proposals of the technically approved bidders. The financial proposals of bids found technically non-acceptable shall be returned without opening Financials to the respective bidders.
g)	The firm / bidder must enclose an affidavit on stamp paper of Rs.100/- that the firm / bidder has not been blacklisted from any government department. If at any stage the firm / bidder is found blacklisted, the bid shall be rejected / not considered.
h)	Procurement Agency may reject all or any bid subject to the relevant provision of SPPRA Rules. All terms and conditions of SPPRA shall be applicable.
